- 9 Whereas: This purchase or activity reflects the genuine students interest and enhances the educational,
10 social, cultural, and recreational interests of the University of North Florida students and;
- 11 Whereas: The Club, ETA Sigma Gama is looking to enhance the cultural and social interests of the
12 students of the University of North Florida, and;
- 13 Whereas: ETA Sigma Gama, in order to further enhance the cultural and social interests of the students
14 of the University of North Florida, is seeking funding for travel to the American Alliance of
15 Health in San Diego, CA from March 29th, 2011 to April 2nd, 2011;
