5 Senate, responsible for funding only those entities that comply with the Student Government
6 mission which is to represent student concerns in all university wide matters while
7 developing and promoting programs and activities of practical value and interest to students,

- 9 Whereas: This purchase or activity reflects the genuine students interest and enhances the educational,
10 social, cultural, and recreational interests of the University of North Florida students and;
- 11 Whereas: The Club, Printer's Guild is looking to enhance the cultural and social interests of the
students of the University of North Florida, and;
- 13 Whereas: Printer's Guild, in order to further enhance the cultural and social interests of the students of
14 the University of North Florida, is seeking funding for travel to the Southern Graphics
15 Conference in the Sam Fox School of Design in Washington, St. Louis from March 16th,
16 2011 to March 19th, 2011;
- 17 Whereas: Printer's Guild is requesting funding for the below items:
