SENATE LEGISLATION

SB-11S-2505

1 *SB-11S-2505:Deputy Attorney General Update*

- 2 Whereas: The Student Government of the University of North Florida was established to represent student
3 concerns in all University wide matters; and
- 4 Whereas: The Student Senate is the legislative body of the University of North Florida's Student Government
5 given the responsibility of carrying out such legislative acts that are necessary and proper for the
6 Student Body of the University of North Florida; and
- 7 Whereas: Legislation dealing with necessary and proper statutory revisions shall be considered by the student
8 senate; and whereas Article II Section VA Meeting of the Senate;
- 9 Whereas: Chapter 704 of Title VII deals with Disposition of Notification of Noncompliance;
- 10 Whereas: Title VII is in need of a minor revision;
- 11 Whereas: The following revisions will be made to Title VII: Chapter 704 and 706;

12 **Chapter 704: Disposition of Notification of Noncompliance**

14 704.1 Seven (7) copies of the "Notification of Noncompliance" shall be made. The Senate
15 President, Student Body President, Chief Justice, Attorney General, Deputy General, and the
16 Senate Committee that has Jurisdiction as defined in 702.1.C.1 all are served within 24 hours of
17 issuance. The party issuing the "Notification of Noncompliance" must also retain a copy.

19 **Chapter 706: Deputy Attorney General's Responsibility**

21 ~~706.1 As outlined in Title III, the Deputy Attorney General may advise the accused party on all~~
22 ~~relevant legal matters pertaining to the noncompliance and assist the accused party in their~~
23 ~~defense.~~

26 ~~706.2 The Deputy Attorney General shall serve as the defense council upon the request of the~~
27 ~~accused party.~~

29 Furthermore: Let it be enacted, by the University of North Florida Student Government that the proposed
30 revisions to Title VII be made effective July 1st, 2011.
