## SENATE LEGISLATION SB-11S-2506

1		SB-11S-2506: 2011 – 2012 Activity and Service Fee Fiscal Budget
2 3	Whereas:	The Student Government of the University of North Florida was established to represent student concerns in all University wide matters, and;
4 5 6 7 8	Whereas:	The Budget and Allocations Committee is a standing committee of the Student Government Senate, responsible for funding only those entities that comply with the Student Government mission which is to represent student concerns in all university wide matters while developing and promoting programs and activities of practical value and interest to students, and;
9 10	Whereas:	The $2011 - 2012$ Balanced Budget was placed on display in the Student Government Office on February $14^{th}$ , 2010 at 8:00 am, and;
11	Whereas:	The Open forum was held on February 16 <sup>th</sup> , 2010 from 1:00 – 3:00 pm, and;
13 14 15 16	Whereas:	Title VIII states in 822.2 "The B&A approved budget shall be posted within two business days of approval and shall be displayed in public view for a minimum of five business days prior to the Senate meeting in which it will be placed on the agenda. During the period a campus-wide open forum will be conducted by the B&A Chair to explain the budget process and the B&A recommended budget.
17 18 19	Therefore:	Let it be enacted, by the University of North Florida Student Government, that the proposed attached 2011 – 2012 Balanced Activity and Service Fee Budget be accepted with provisionary language and riders.
