### SB-11S-2508: Resolution Campus Ministry

10 social, cultural, and recreational interests of the University of North Florida students and;

11 Whereas: The Club, Resolution Campus Ministry is looking to enhance the cultural and social interests  
12 of the students of the University of North Florida, and;

13 Whereas: Resolution Campus Ministry, in order to further enhance the cultural and social interests of  
14 the students of the University of North Florida, is seeking funding for travel to the Campus  
15 Harvest Conference in Durham, North Carolina from March 25<sup>th</sup>, 2011 to March 27<sup>th</sup>, 2011
