# SENATE LEGISLATION

## SB-11S-2512

1 *SB-11S-2512 : Osprey Productions Revision*

2 Whereas: The Student Government of the University of North Florida was established to  
3 represent student concerns in all University wide matters; and

4 Whereas: The Student Senate is the legislative body of the University of North Florida's  
5 Student Government given the responsibility of carrying out such legislative acts that  
6 are necessary and proper for the Student Body of the University of North Florida;  
7 and

8 Whereas: Legislation dealing with necessary and proper statutory revisions shall be considered  
9 by Student Senate;

10 Whereas: Title XI Chapter 1102.1 is in need of revision. Currently, Title XI describes the role  
11 of Osprey Productions as an Agency of Student Government. It lists various events  
12 that are no longer under their control and it is not up to date.

13 Therefore; The following revisions are being made to Title XI;

14 **TITLE XI: THE EXECUTIVE AGENCY STATUTE**

15 **Chapter 1102: Osprey Productions**

16 1102.1 Creation and Purpose

19 B. Osprey Productions plans and produces a variety of entertainment events for the student  
20 body. Regular programming includes the outdoor festivals featuring live music and  
21 refreshments on the University Green, Coxwell Amphitheatre, and major concerts in the  
22 University of North Florida Arena, and the annual Earth Music Festival every Spring.  
23 Members have the opportunity to develop programming ideas for campus entertainment as  
24 well as to work in all facets of event planning, promotion, and production.

26 Furthermore: Let it be enacted, by the University of North Florida Student Government that the  
27 proposed revisions to Title XI be made effective immediately.
