# SENATE LEGISLATION

## SB-11S-2513

1 *SB-11S-2513 : Executive Agency Reform I*

2 Whereas: The Student Government of the University of North Florida was established to  
3 represent student concerns in all University wide matters; and

4 Whereas: The Student Senate is the legislative body of the University of North Florida's  
5 Student Government given the responsibility of carrying out such legislative acts that  
6 are necessary and proper for the Student Body of the University of North Florida;  
7 and

8 Whereas: Legislation dealing with necessary and proper statutory revisions shall be considered  
9 by Student Senate; and

10 Whereas: Title XI is in need of revision. For the sake of clarity and the extension of legislative  
11 oversight in the process of termination it would be fitting to provide a review of the  
12 funds by the Budget and Allocations Committee.

13 Therefore; The following revisions are being made to Title XI;

14 **TITLE XI: THE EXECUTIVE AGENCY STATUTE**

16 **Chapter 1100: Executive Agency Statute**

18 **1100.5 Termination**

19  
20 B. Student Government Agencies shall be terminated or temporarily suspended upon  
21 enactment of a bill. Upon termination of an agency, it will be deleted from the Student Body  
22 Statutes Student Government Statutes, Title XI: The Executive Agency Statute. Student  
23 Government Executive Agencies. If an agency is terminated, its budget is automatically  
24 transferred to the Student Senate Unallocated Reserves Account. If an agency is terminated,  
25 its budget will be sent to the Budget and Allocations Committee for review.

27 **Furthermore: Let it be enacted, by the University of North Florida Student Government that the**  
28 **proposed revisions to Title XI be made effective immediately.**
