SB-11S-2514

1 ***SB-11S-2514 : Executive Agency Reform II***

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters; and

4 Whereas: The Student Senate is the legislative body of the University of North Florida's Student
5 Government given the responsibility of carrying out such legislative acts that are necessary
6 and proper for the Student Body of the University of North Florida; and

7 Whereas: Legislation dealing with necessary and proper statutory revisions shall be considered by
8 Student Senate; and

9 Whereas: Title XI is in need of revision. Potential Executive Agencies should originate from the ideas
10 of the individual or group seeking to form it, rather than from an existing club or registered
11 student organizations. This change is necessary in order to facilitate the workings of future
12 Executive Agencies in conjunction with the Executive Legislative and Judicial Branches.

Therefore; The following revisions are being made to Title XI;

20 ~~A. Any persons who want an agency formed must first acquire 20% of the student body~~
21 ~~signatures during the fall semester only. Any individuals or groups seeking to form an~~
22 ~~executive agency must first acquire signatures from 20% of the student body. However,~~
23 ~~current, previous and future clubs and registered student organizations are prohibited from~~
24 ~~becoming an executive agency.~~

26 **Furthermore: Let it be enacted, by the University of North Florida Student Government that the**
27 **proposed revisions to Title XI be made effective July 1st, 2011.**
