1 *SB-11S-2515 : Termination of the African American Student Union*

2 Whereas: The Student Government of the University of North Florida was established to represent student
3 concerns in all University wide matters; and

4 Whereas: The Student Senate is the legislative body of the University of North Florida's Student Government
5 given the responsibility of carrying out such legislative acts that are necessary and proper for the
6 Student Body of the University of North Florida; and

7 Whereas: Legislation dealing with necessary and proper statutory revisions shall be considered by Student
8 Senate; and

9 Whereas: The African American Student Union is being removed from Agency status and needs to be deleted
10 from the Executive Agency Statute;

11 Therefore: The following revisions are being made to Title XI

SB-11S-2515 : Termination of the African American Student Union

The Director is a paid position working to promote cultural and educational enrichment emphasizing the African American culture. Additional duties include maintaining an office, a Web site, an information line, and conducting biweekly meetings.

1101.4 Assistant Director

A. Powers and Duties

The Assistant Director is a paid position working to promote cultural and educational enrichment emphasizing the African American culture. Additional duties include aiding the Director in maintaining an office, a Web site, an information line, and conducting biweekly meetings.

1101.5 Standing Committees

The African American Student Union shall have the right to establish standing committees as the leadership determines necessary.

Standing committees of the AASU include the Public Relations Committee, the Cultural Awareness Committee, the Community Service Committee, the Black History Committee, the Entertainment Committee, and the Scholarship Committee.

1101.1 Termination and Deletion

A. Termination

By call of the Student Senate through legislation passed by majority vote and signed by the Student Body President, the Agency of the Student Government Association known as the African American Student Union will be terminated.

B. Deletion

Upon termination of the Agency, the African American Student Union will be deleted from Title XI: The Executive Agency Statute.

Furthermore: Let it be enacted, by the University of North Florida Student Government that the proposed revisions to Title XI be made effective immediately.
