# SENATE LEGISLATION

## SB-11S-2516

### SB-11S-2516: Change to 2010/2011 Budget Provisionary Language

- 2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;
- 4 Whereas: In representing student concerns, Student Government as a whole believes that this  
5 concern should be addressed; and
- 6 Whereas: Student Government approved the Activity and Service Fee Budget and its Provisionary  
7 Language for the Fiscal Year 2010-2011 in February of 2010; and
- 8 Whereas: The University Administration and the Student Body President have requested a change  
9 to the Provisionary Language; and,
- 10 Whereas: Section 18 of the Budget's Provisionary Language should read:
- 11 "In the event the African American Student Union, becomes an office within Student  
12 Affairs, it will continue to receive its A&S Fee allocated funding through June 30, 2011.  
13 For the next six years, FY 12-13 – FY 16-17, unless the University administration picks  
14 up the funding in whole or part for the African American Student Union Office, SG will  
15 continue to fund at the current allocations of \$39,047 for OPS wages, \$500 for Salary  
16 (police coverage), and \$12,290 for Operating Expenses. Should the administration begin  
17 funding the African American Student Union Office in part or whole during the next six  
18 fiscal years, funding will be pro-rated so that the total amount allocated remains at  
19 \$51,838."
- 20 Therefore: The Student Government of the University of North Florida resolves to make it  
21 known to the University Administration, especially Dr. Mauricio Gonzalez, that  
22 Student Government plans to add Section 18 to the Budget's Provisionary  
23 Language.
- 24 Furthermore: Let it be enacted by the University of North Florida Student Government that the  
25 proposed revisions be made effective immediately.
