SB-11SA-2529

1 *SB-11SA-2529: North Florida Wrestling*

- 2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;
- 4 Whereas: The Budget & Allocations Committee is a standing committee of the Student Government
5 Senate, responsible for funding only those entities that comply with the Student Government
6 mission, which is to represent student concerns in all university wide matters while
7 developing and promoting programs and activities of practical value and interest to students,
8 and;
- 9 Whereas: This purchase or activity reflects the genuine students interest and enhances the social,
10 cultural, and recreational interests of the University of North Florida students and;
- 11 Whereas: North Florida Wrestling, in order to further enhance the social, cultural, and recreational
12 interests of the students of the University of North Florida, is seeking funding for wrestling
equipment.
- 14 Whereas: North Florida Wrestling is requesting funding for the below items:
