### SB-11SA-2530: Club Fest

- 2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;
- 4 Whereas: The Budget & Allocations Committee is a standing committee of the Student Government  
5 Senate, responsible for funding only those entities that comply with the Student Government  
6 mission, which is to represent student concerns in all university wide matters while  
7 developing and promoting programs and activities of practical value and interest to students,  
8 and;
- 9 Whereas: This purchase or activity reflects the genuine students interest and enhances the social,  
10 cultural, and recreational interests of the University of North Florida students and;
- 11 Whereas: Club Alliance, in order to further enhance the social, cultural, and recreational interests of the  
12 students of the University of North Florida, is seeking funding for the annual Club Fest on  
13 Thursday, September 22<sup>nd</sup>, 2011 on the Coxwell Amphitheater.
- 14 Whereas: Club Alliance is requesting funding for the below items:
