SB-11SA-2532 : The Enabling Act

2 Whereas: The Student Government of the University of North Florida was established to
3 represent student concerns in all University wide matters; and

4 Whereas: The Student Senate is the legislative body of the University of North Florida's
5 Student Government given the responsibility of carrying out such legislative acts that
6 are necessary and proper for the Student Body of the University of North Florida;
7 and

8 Whereas: Legislation dealing with necessary and proper statutory revisions shall be considered
9 by Student Senate; and

10 Whereas: Title IV and Title V are in need of revision.

11 Whereas: The Executive Branch derives its authority from the Student Body President in the
12 same manner as the Legislative Branch and the Senate President, and the Judicial
13 Branch and Chief Justice. Moreover, as the Student Body President reserves the right
14 to dismiss any member of his cabinet, the Senate President should be able to dismiss
15 members of the Legislative Cabinet, as should the Chief Justice be able to dismiss
16 the Associate Chief Justice.

17 Therefore; the following revisions are being made to Title IV and Title V;

18 **TITLE IV: THE LEGISLATIVE BRANCH**

19 **Chapter 402: Organization of the Student Senate**

20 **402.5 Legislative Cabinet**

21 E. The Senate President may dismiss any member of the
22 legislative cabinet at any time if he or she feels it is in the best
23 interest of the Student Body. The Senate may override the
24 Senate President by a two-thirds (2/3) vote at the next
25 regularly-scheduled Senate meeting.

27 **Chapter 506: Responsibilities of the Chief Justice**

SB-11SA-2532 : The Enabling Act

506.3 The Chief Justice may dismiss the Associate Chief Justice at any time if he or she feels it is in the best interest of the Student Body. The Judicial Council may override the Chief Justice by a two-thirds (2/3) vote at the next regularly-scheduled Judicial Council meeting.

Furthermore: Let it be enacted, by the University of North Florida Student Government that the proposed revisions to Title IV and Title V be made effective July 1st, 2011.
