SENATE LEGISLATION SB-11SA-2532

1		SB-11SA-2532: The Enabling Act
2 3	Whereas:	The Student Government of the University of North Florida was established to represent student concerns in all University wide matters; and
4 5 6 7	Whereas:	The Student Senate is the legislative body of the University of North Florida's Student Government given the responsibility of carrying out such legislative acts that are necessary and proper for the Student Body of the University of North Florida; and
8 9	Whereas:	Legislation dealing with necessary and proper statutory revisions shall be considered by Student Senate; and
10	Whereas:	Title IV and Title V are in need of revision.
13 14 15 16	Whereas:	The Executive Branch derives its authority from the Student Body President in the same manner as the Legislative Branch and the Senate President, and the Judicial Branch and Chief Justice. Moreover, as the Student Body President reserves the right to dismiss any member of his cabinet, the Senate President should be able to dismiss members of the Legislative Cabinet, as should the Chief Justice be able to dismiss the Associate Chief Justice.

1	SB-11SA-2532: The Enabling Act
2 3 4 5	The Chief Justice may dismiss the Associate Chief Justice at any time if he or she feels it is in the best interest of the Student Body. The Judicial Council may override the Chief Justice by a two-thirds (2/3) vote at the next regularly-scheduled Judicial Council meeting.
6 7 8	Furthermore: Let it be enacted, by the University of North Florida Student Government that the proposed revisions to Title IV and Title V be made effective July 1 st , 2011.
