JR-11SB-2537

1 *JR-11SB-2537 : Proclamation of Support for the Lend-A-Wing Food Pantry*

2 Whereas: The Student Government of the University of North Florida was established to
3 create a representative government through which the individual student voice can
4 be heard, and which students can actively participate in this University by promoting
5 cooperation among the Student Body, Faculty, and Administration, and;

6 Whereas: The Student Government of the University of North Florida was established to
7 represent student concerns in all University wide matters; and

8 Whereas: The Student Government of the University of North Florida deeply believes in the
9 noble principles of altruism and offering support to those in need, especially fellow
10 Ospreys.

11 Whereas: The Student Government of the University of North Florida is proud to lend its
12 support and recognition to the Volunteer Center and the Lend-A-Wing Food Pantry
13 initiative for through this great endeavor the hardships endured by many of our
14 fellow ospreys may be lightened.

15 Whereas: The Lend-A-Wing Food Pantry would exist as a beacon of hope and provider of
16 sustenance for the thousands of students who at times may lack the essential
17 resources needed to meet all of their basic needs throughout the school year.

18 **Therefore:** Let it be resolved that the Student Government of the University of North Florida
19 believes that the creation of the Lend-A-Wing Food Pantry would not only be in the
20 best interest of the student body, but also be in accordance with the University of
21 North Florida's Strategic Plan 2009-2014, specifically "Goal 4: To affirm the
22 University's public responsibility through civic and community engagement."
