# SENATE LEGISLATION

## SB-11SB-2542

### SB-11SB-2542: Fiscal Year 2011/2012 Year-End Encumbrances

2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;

4 Whereas: The Budget & Allocations Committee is a standing committee of the Student Government  
5 Senate, responsible for funding only those entities that comply with the Student Government  
6 mission which is to represent student concerns in all university wide matters while  
7 developing and promoting programs and activities of practical value and interest to students,  
8 and;

9 Whereas: This purchase or activity reflects the genuine student interest and enhances the educational,  
10 social, cultural, and recreational interests of the University of North Florida students and;

11 Whereas: The provisional language of the 2011/2012 Activity & Service Fee Budget  
12 specifies that "all 2010/2011 year-end encumbrances shall be funded from  
13 402097...following the normal legislative process" and;

14 Whereas: The following Activity & Service Fee funded entities entered FY 2011/2012 with  
15 the following outstanding encumbrances from FY 2010/2011:
