JR-11SB-2543

1 *JR-11SB-2543: Recognizing Mrs. Laurel Kendall*

2 Whereas: The Student Government of the University of North Florida's mission shall be to
3 serve the students by passing on their behalf acts, bills, and resolutions that
4 benefit the Student Body at-large. Furthermore, the Senate shall represent
5 Students in all university-wide Local, State, and National concerns as their

9 numerous staff capacities within Student Government; and

11 Whereas: During this time, Laurel has always been a shining example of servant
12 leadership. She has remained true to the values she expresses to all of the
13 students who serve within the walls of Building 58E, specifically her insistence
14 that students are our university's most valuable assets. Laurel has always viewed
15 the needs of the students as her topmost priority and has been an advisor from
16 whom all members of Student Government have received valuable guidance;
