### SB-11F-2548 PRSSA

2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government  
5 Senate, responsible for funding only those entities that comply with the Student Government  
6 mission which is to represent student concerns in all university wide matters while  
7 developing and promoting programs and activities of practical value and interest to students,  
8 and;

9 Whereas: This purchase or activity reflects the genuine students interest and enhances the educational,  
10 social, cultural, and recreational interests of the University of North Florida students and;

11 Whereas: The students of the Public Relations Student Society of America (PRSSA), are Activity and  
12 Service fee paying students, looking to enhance the cultural and social interests of the  
13 students of the University of North Florida, and;

14 Whereas: The PRSSA, in order to further enhance the cultural and social interests of the students of the  
15 University of North Florida, are seeking funding for travel to the PRSSA National  
16 Conference of 2011 in Orlando, Florida on October 14<sup>th</sup> to October 17<sup>th</sup>, 2011.

17 Whereas: The PRSSA, is requesting funding for the below items:

18	Registration:	4 Students	X	\$295.00 per person	= \$1180.00
19	Lodging:	1 Room x 4 Nights	X	\$193.88 per person	= \$775.50
