SENATE LEGISLATION

SB-11F-2552

1 **SB-11F-2552: Transfer of Funds to the International Center**

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;

4 Whereas: The Budget & Allocations Committee is a standing committee of the Senate, responsible
5 for funding only those entities that comply with the Student Government mission, which
6 is to represent student concerns in all university wide matters while developing and
7 promoting programs and activities of practical value and interest to students, and;

8 Whereas: Title VIII, Chapter 834.2, A states "Requests for budget transfers in decentralized
9 indexes, including transfers between funding categories, shall be submitted in writing to
10 the B&A Committee at least five business days prior to the B&A Committee Meeting,"
11 and;

12 Whereas: On August 19th, 2011 the Director of the Intercultural Center for PEACE requested that
13 funds be transferred to the International Center for the purpose of hosting the annual
14 World Fest event on campus, and;

15 Whereas: This transfer reflects the genuine students interest and enhances the, social, cultural, and
16 recreational concerns of the University of North Florida students and;

17 Whereas: The Intercultural Center for PEACE was approved \$2,459.00 for the aforementioned
18 event however, the Intercultural Center of PEACE has requested that the oversight of this
19 event be transferred to the International Center, and;

20 Whereas: In order for the International Center to host World Fest, it is requesting that \$2,549.00 be
21 transferred from Line 3 in the Intercultural Center for Peace Index 140012 to a new line
22 in the International Center Index 402021.

23 **TOTAL: \$2,459.00**

24 **Therefore: Let it be enacted, by the University of North Florida Student Government,**
25 **that \$2,459 from the Intercultural Center for Peace Index 140012 be**
26 **transferred to the International Center Index 402021.**
