# SENATE LEGISLATION

## SB-11F-2553

1 *SB-11F-2553: Elections Results Fall 2011*

2 Whereas: The Student Government of the University of North Florida was established to  
3 represent student concerns in all University wide matters; and

4 Whereas: Title VI, Chapter 600.1 A establishes the necessity for the University of North  
5 Florida Student Government to hold "General, Special, and/or Inter-Collegiate  
6 Elections occurring during the Fall and Spring Semesters to elect a Student Body  
7 President, Vice-President, and Student Senators," and;

8 Whereas: Under Title VI, 611.1C, "At the next Senate meeting, the Senate must vote on  
9 validation of the election. The election can only be validated if a majority of Senators  
10 present at the meeting vote "yes" on the bill to validate the election;" and

11 Whereas: 611.3 Installation, "The Installation process shall begin within five (5) business  
12 days of the last day of any election. Candidates with the most votes shall assume all  
13 abilities and responsibilities of office when and only when, in accordance with  
14 specifications of this title and in this order;" and

15 Whereas: 611.3.A- "A bill to validate the election is posted by the Election Supervisor."

16 Therefore: I, Britt Stromquist, Elections Supervisor of the Fall 2011 General Elections,  
17 present the Results to Senate:
