# SENATE LEGISLATION

## SB-11F-2556

1 *SB-11F-2556: Student Government Executive*

2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;

4 Whereas: The Budget & Allocations Committee is a standing committee of the Student Government  
5 Senate, responsible for funding only those entities that comply with the Student Government  
6 mission, which is to represent student concerns in all university wide matters while  
7 developing and promoting programs and activities of practical value and interest to students,  
8 and;

9 Whereas: This purchase or activity reflects the genuine students interest and enhances the social,  
10 cultural, and recreational interests of the University of North Florida students and;

11 Whereas: Student Government Executive, in order to further enhance the logistical efficiency of the  
12 Student Government Staff of the University of North Florida, is seeking funding to renovate  
13 room 3106 of the 3<sup>rd</sup> floor of the Student Union, Building 58 East.

14 Whereas: Student Government Executive is requesting funding for the below items:

15 Construction	= \$16,604.00
16 Building Permit	= \$150.00

20 Therefore: Let it be enacted, by the University of North Florida Student Government, that \$16,754  
21 be taken from Special Request Index 402097 to be used to pay for the above items.
