# SENATE LEGISLATION

## SB-11F-2563

1 *SB-11S-2563: North Florida Wrestling*

2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student  
5 Government Senate, responsible for funding only those entities that comply with the  
6 Student Government mission which is to represent student concerns in all university wide  
7 matters while developing and promoting programs and activities of practical value and  
8 interest to students, and;

9 Whereas: This purchase or activity reflects the genuine students interest and enhances the  
10 educational, social, cultural, and recreational interests of the University of North Florida  
11 students and;

12 Whereas: North Florida Wrestling, in order to enhance the cultural and social interests of the  
13 students of the University of North Florida, are seeking funding for travel to the  
14 Northwest Georgia Trade and Convention Center in Dalton, Georgia on January 26<sup>th</sup> to  
15 January 29<sup>th</sup>, 2012.

16 Whereas: North Florida Wrestling is requesting funding for the below items:

17	Registration:	\$500	=	\$500.00
18	Lodging:	\$92.66 per room X 4 rooms X 3 Nights	=	\$1,111.92
19	Transportation:	\$186.77 per vehicle X 2 vehicles	=	\$373.54
20	Fuel:	\$165.73 per vehicle X 2 vehicles	=	\$331.46

22	<b>Total:</b>		=	<b>\$2,316.89</b>
