SENATE LEGISLATION SB-12S-2564

1		SB-12S-2564 : Election Courts Creation Act
2 3	Whereas:	The Student Government of the University of North Florida was established to represent student concerns in all University wide matters; and
4 5 6 7	Whereas:	The Student Senate is the legislative body of the University of North Florida's Student Government given the responsibility of carrying out such legislative acts that are necessary and proper for the Student Body of the University of North Florida; and
8 9	Whereas:	Legislation dealing with necessary and proper statutory revisions shall be considered by Student Senate;
10	Whereas:	Title V is in need of revision;
11 13 14	Whereas:	In order to have a successfully functioning government it is essential to have a sound judicial system to adjudicate disputes. This measure ensures that there is a fair and just process for all students who file election complaints and if they so chose, appeal those complaints to a higher body.
15	Therefore;	The following revisions are being made to Title V;
19		TITLE V: THE JUDICIAL BRANCH
17 18 19	Chapt	ter 508: Election Code Violation Process
20 21		A. The Judicial Council shall have purview over all filed election violations.
22 23 24		B. <u>At the start of each election cycle the Judicial Council shall be separated into</u> two courts, the Elections Primary Court and the Elections Supreme Court.
25 26 27 28 29 30 31 32 23		C. The Elections Primary Court shall be composed of the Associate Chief Justice and two (2) Associate Justices appointed by the Chief Justice. All violations will first be reviewed for merit and adjudicated by this court. All rulings made by the Elections Primary Court may be appealed to the Elections Supreme Court.

2 3 4 5 6 7 8 9	D. <u>The Elections Supreme Court shall be composed of the Chief Justice, all</u> <u>members of the Elections Primary Court and the remaining Justices who sit</u> <u>on the Judicial Council. The Elections Supreme Court will hear all appeals</u> <u>and may affirm, reverse or alter all rulings made by the Elections Primary</u> <u>Court. All decisions made by the Elections Supreme Court shall be final.</u>
