SENATE LEGISLATION SB-12S-2567

1		SB-12S-2567 : Party Registration Amendment Act
2 3	Whereas:	The Student Government of the University of North Florida was established to represent student concerns in all University wide matters; and
4 5 6 7	Whereas:	The Student Senate is the legislative body of the University of North Florida's Student Government given the responsibility of carrying out such legislative acts that are necessary and proper for the Student Body of the University of North Florida; and
8 9	Whereas:	Legislation dealing with necessary and proper statutory revisions shall be considered by Student Senate; and
10	Whereas:	Title VI is in need of revision.
11 13 14	Whereas: .	The Party Registration process is in need of minor revision. Moreover, to ensure that no individual attempts to become party chair of multiple parties and to eliminate the possibility of outside influence interfering within the student government system, these measures are essential.

19 20	607.4	Party Registration Form
21 22 23	C.	Each party must have a designated party chair. Only A&S-fee paying students may become party chairs. Party chairs do not have to be candidates.

If the current party chair is no longer an A&S-fee paying student, he/she shall be allowed to remain party chair and retain party rights until the end of the next two (2) election cycles. <u>However, the party is no longer eligible to be active if the party chair is no longer an A&S-fee paying student.</u>

SENATE LEGISLATION SB-12S-2567

University of North Florida SB-12S-2567 : Party Registration Amendment Act b. No individual may be the party chair of more than one party simultaneously. If a party chair would like to start a new party, he/she must first declare his/her current party inactive and forfeit all exclusive rights to that party. Furthermore: Let it be enacted, by the University of North Florida Student Government that the

proposed revisions to Title VI be made effective July 1st, 2012.
