# SENATE LEGISLATION

## JR-12S-2571

1 **JR-12S-2571 : UNF Student Body Opposition to the Removal of the FSA Chair from the Board of Governors**

2 **Whereas:** The Student Government of the University of North Florida was established to  
3 create a representative government through which the individual student voice can  
4 be heard, and which students can actively participate in this University by promoting  
5 cooperation among the Student Body, Faculty, and Administration, and;

6 **Whereas:** The Student Government of the University of North Florida was established to  
7 represent student concerns in all University wide matters; and

8 **Whereas:** The Student Government of the University of North Florida is deeply concerned  
9 about the possibility of our student body losing its ability to cast a vote on the  
10 student representative to the Florida SUS Board of Governors as outlined in HJR  
11 931 and any similar or subsequent house and senate bills.

12 **Therefore:** Let it be resolved that the Student Government of the University of North Florida  
13 strongly opposes any legislation from our state bodies which seeks to curb Florida  
14 students' ability to elect our student representative to the Board of Governors.

15 **Furthermore:** Let this resolution be forwarded to the members of the Florida House of  
16 Representatives, the members of the Florida Senate, BOG Chairman Dean  
17 Colson, UNF VP – Governmental Affairs Janet Owen, and the UNF Board of  
18 Trustees.
