# SENATE LEGISLATION

## SB-12S-2572

### *SB-12S-2572 : The Lighthouse Act*

2   Whereas:       The Student Government of the University of North Florida was established to  
3                    represent student concerns in all University wide matters; and

4   Whereas:       The Student Senate is the legislative body of the University of North Florida's  
5                    Student Government given the responsibility of carrying out such legislative acts that  
6                    are necessary and proper for the Student Body of the University of North Florida;  
7                    and

8   Whereas:       Legislation dealing with necessary and proper statutory revisions shall be considered  
9                    by Student Senate; and

10   Whereas:       Title XII is in need of revision.

11   Whereas:       The Lighthouse program has been in existence for over a year now. In order to  
12                    better define and regulate the program these measures are being introduced. Further,  
13                    through this proposal Lighthouse shall be more organized, transparent and effective.

### **TITLE XII: THE STUDENT ADVOCACY COMMITTEE STATUTES**

#### **Chapter 1203: Lighthouse**

15                    1203.1        The Student Advocacy Committee is responsible for conducting Lighthouse,  
16                    a brief survey of the student body addressing issues of student interest.

17                    1203.2        Lighthouse should be conducted at least once a month. At the first senate of  
18                    each month, the Student Advocacy Chair shall distribute a schedule of dates  
19                    and a sign up form for Lighthouse.

20                    1203.3        Every Senator shall participate in at least one (1) Lighthouse per month. If a  
21                    Senator fails to attend a Lighthouse, one (1) absentee point will be assessed.

22                    1203.4        The questions for Lighthouse shall be drafted by the Student Advocacy Chair  
23                    and must be approved with majority vote by the Student Advocacy  
24                    Committee. Questions shall pertain to issues that could potentially affect the  
25                    student body.

26                    1203.5        Each Senator participating in Lighthouse is required to survey at least 35  
27                    students.

1203.6 The Student Advocacy Chair shall present the results of the Lighthouse surveys during his/her Committee Chair Report at the next regularly scheduled Senate meeting. The results shall be distributed to the appropriate branches or individuals who can evaluate the results and gain a better understanding of student opinion.
