# SENATE LEGISLATION

## SB-12S-2573

### SB-12S-2573 : Title XII Revision Act

- 1
- 2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters; and
- 4 Whereas: The Student Senate is the legislative body of the University of North Florida's Student  
5 Government given the responsibility of carrying out such legislative acts that are necessary  
6 and proper for the Student Body of the University of North Florida; and
- 7 Whereas: Legislation dealing with necessary and proper statutory revisions shall be considered by  
8 Student Senate; and
- 9 Whereas: Title XII is in need of revision.
- 10 Whereas: The current non-voting Ex-Officio members of the SAC Committee per statutes are not  
11 entirely accurate or representative of the current state of the SAC Committee. Moreover, in  
12 order to display this, the Student Advocate shall be a non-voting Ex-Officio of the SAC  
13 committee as he/she maintains the same goals as the committee. And the Faculty  
14 Association Representative seldom attends SAC meetings and it is improper for an  
15 individual who is outside of the student government system to be an Ex-Officio of any  
16 student government committee.

### 17 TITLE XII: THE STUDENT ADVOCACY COMMITTEE STATUTES

#### 18 Chapter 1200: Student Advocacy Committee

19

20 1200.2 The Student Advocacy Committee shall be composed of up to eleven (11)  
21 Senators including the Chairman and ten (10) Senators. All voting members  
22 of the committee will be elected or appointed senators including the Vice-  
23 Chairperson. Non-voting Ex-Officio members shall include Constitutions  
24 and Statutes (~~CSC~~) Chairperson, Budget and Allocations (~~B&A~~) Chairperson,  
25 Elections and Appointments ~~Committee~~ (~~EAC~~) Chairperson, Senate  
26 President, Senate Pro-Tempore, Student Advocate and Student Government  
27 Advisor. ~~Faculty Association Representative; SG Advisor.~~

29 **Furthermore: Let it be enacted, by the University of North Florida Student Government that the**  
30 **proposed revisions to Title XII be made effective immediately.**
