1		SB-12S-2573: Title XII Revision Act	
2 3	Whereas:	The Student Government of the University of North Florida was established to represent student concerns in all University wide matters; and	
4 5 6	Whereas:	The Student Senate is the legislative body of the University of North Florida's Student Government given the responsibility of carrying out such legislative acts that are necessary and proper for the Student Body of the University of North Florida; and	
7 8	Whereas:	Legislation dealing with necessary and proper statutory revisions shall be considered by Student Senate; and	
9	Whereas:	Title XII is in need of revision.	
10 11 12 , 14 15 16	Whereas:	The current non-voting Ex-Officio members of the SAC Committee per statutes are not entirely accurate or representative of the current state of the SAC Committee. Moreover, in order to display this, the Student Advocate shall be a non-voting Ex-Officio of the SAC committee as he/she maintains the same goals as the committee. And the Faculty Association Representative seldom attends SAC meetings and it is improper for an individual who is outside of the student government system to be an Ex-Officio of any student government committee.
