SENATE LEGISLATION

SB-12S-2574

1 *SB-12S-2574 : 2012 – 2013 Activity and Service Fee Fiscal Budget*

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government
5 Senate, responsible for funding only those entities that comply with the Student Government
6 mission which is to represent student concerns in all university wide matters while
7 developing and promoting programs and activities of practical value and interest to students,
8 and;

9 Whereas: The 2012 – 2013 Balanced Budget was placed on display in the Student Government Office
10 on February 21st, 2012 at 8:00 am, and;

11 Whereas: The Open forum was held on February 23rd, 2012 from 12:00 – 1:00 pm, and;

12 Whereas: Title VIII states in 822.2 “The B&A approved budget shall be posted within two business
13 days of approval and shall be displayed in public view for a minimum of five business days
14 prior to the Senate meeting in which it will be placed on the agenda. During the period a
15 campus-wide open forum will be conducted by the B&A Chair to explain the budget process
16 and the B&A recommended budget.

17 Therefore: Let it be enacted, by the University of North Florida Student Government, that the
18 proposed attached 2012 – 2013 Balanced Activity and Service Fee Budget be accepted
19 with provisionary language and riders.
