SB-12S-2576

1 *SB-12S-2576: Young Vessels of God – Campus Harvest*

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government
5 Senate, responsible for funding only those entities that comply with the Student Government
6 mission which is to represent student concerns in all university wide matters while
7 developing and promoting programs and activities of practical value and interest to students,
8 and;

9 Whereas: This purchase or activity reflects the genuine students interest and enhances the educational,
10 social, cultural, and recreational interests of the University of North Florida students and;

11 Whereas: The students of the Young Vessels of God (YVOG), are Activity and Service fee paying
12 students, looking to enhance the cultural and social interests of the students of the University
13 of North Florida, and;

14 Whereas: YVOG, in order to further enhance the cultural and social interests of the students of the
15 University of North Florida, are seeking funding for travel to Campus Harvest in Durham,
16 North Carolina on March 23rd to 25th, 2012.

17 Whereas: YVOG, is requesting funding for the below items:

18	Registration:	23 students	X	\$19.00 per person	= \$437.00
19	Lodging:	4 rooms	X 2 nights	X \$72.90 per night	= \$583.20
20	Transportation:	4 vehicles	X	\$156.65 per vehicle	= \$626.60
21	Fuel:	4 vehicles	X 63.08 miles	X \$3.36 per gallon	= \$847.80

23	Total:				= \$2,494.60

25 **Therefore:** Let it be enacted, by the University of North Florida Student Government,
26 that \$2,495 be expended from the Student Conference Travel Index 402028
27 to pay for the above referenced items.
