SB-12S-2578 - Title III: Chapter 309 - Executive Transition Period

Whereas: The Student Government of the University of North Florida was established to represent student concerns in all University wide matters, and;

Whereas: The Senate is the legislative body of the University of North Florida's Student Government, given the responsibility of carrying out such legislative acts that are necessary and proper for the Student Body of the University of North Florida; and

Whereas: Legislation dealing with necessary and proper statutory revisions shall be considered by the Senate; and

Whereas: The Constitution and Statutes Committee is the standing committee responsible for reviewing the SG Constitution and Statutes in order to recommend any change to the Senate when necessary; and

Whereas: Revisions are necessary in order to provide a smooth transition between administrations;

Therefore: The following changes need to be made to Title III: Chapter 309: Executive Transition Period, and should read as follows:

Chapter 309: Executive Transition Period

309.5 In the absence of any outstanding election disputes, the swearing in of the new administration shall be held at the SG Annual Banquet which shall occur no earlier than three (3) weeks before the end of the spring semester and no later than the conclusion of that semesters' finals week. The swearing in of the new administration must be held within fifteen (15) business days after the final elections complaint has been resolved.
