# SENATE LEGISLATION

## SB-12S-2579

### SB-12S-2579 : The Ballot Fix Act of Spring 2012

4 Whereas: The Student Government of the University of North Florida was established to represent  
5 student concerns in all University wide matters; and

6 Whereas: The Student Senate is the legislative body of the University of North Florida's Student  
7 Government given the responsibility of carrying out such legislative acts that are necessary  
8 and proper for the Student Body of the University of North Florida; and

9 Whereas: Legislation dealing with necessary and proper statutory revisions shall be considered by  
10 Student Senate; and

11 Whereas: Title VI needs to reflect the ballot that ITS has generously produced for us,

12 Therefore; the following revisions are being made to Title VI;

#### 13 14 Chapter 611: The Ballot

##### 15 A. Format

18 2. Candidates shall be listed in alphabetical order by their last  
19 names in accordance with their party affiliation. There shall  
20 be separate groupings for each party. Each party group will  
21 appear in alphabetical order. Candidates who do not affiliate  
22 with a party will appear in a grouping called "No Party  
23 Affiliation." ~~The ballot shall identify each candidate's party~~  
24 ~~affiliation by including the party title in parenthesis after the~~  
25 ~~candidate's name. If there are independent candidates, the~~  
26 ~~ballot shall state "No Party Affiliation" instead of a party~~  
27 ~~name.~~

28  
29 6. Unopposed candidates shall be deemed to have voted for him  
30 or herself and declared the winner by acclamation. No  
31 election for the respective seat shall be held.

34 Therefore: Let it be enacted, by the University of North Florida Student Government that the  
35 proposed revisions to Title VI be made effective immediately.
