# SENATE LEGISLATION

## SB-12S-2588

1 *SB-12S-2588: Osprey TV*

2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;

4 Whereas: The Budget & Allocations Committee is a standing committee of the Student Government  
5 Senate, responsible for funding only those entities that comply with the Student Government  
6 mission, which is to represent student concerns in all university wide matters while  
7 developing and promoting programs and activities of practical value and interest to students,  
8 and;

9 Whereas: This purchase or activity reflects the genuine students interest and enhances the social,  
10 cultural, and recreational interests of the University of North Florida students and;

11 Whereas: Osprey TV, in order to further enhance the social, cultural, and recreational interests of the  
12 students of the University of North Florida, is seeking funding to remove the wall in room  
13 2217.

14 Whereas: Osprey TV is requesting funding for the below items:
