

A RESOLUTION

WHEREAS, the early history and records of BLUE SHIELD OF FLORIDA, INC. indicate that
EDWARD JELKS, M. D.

WAS named in the Charter of Florida Medical Service Corporation (now Blue Shield of Florida, Inc.), as one of the five original subscribers to the Corporation's Charter;

WAS elected to the Blue Shield Board of Directors at the Annual Meeting of Active Members on June 20th, 1946 and served continuously as a member of this Board until April 27, 1952. (A portion of this period from June 20th, 1946 until June 25th, 1947, he was Assistant Treasurer of the Florida Blue Shield Board of Directors.)

WAS also one of the seventeen members of the original Board of Directors of the Florida Hospital Service Corporation (later renamed Blue Cross of Florida, Inc.). He served continuously in this capacity, and as member of the Executive Committee, from that time until January 1970, when personal reasons demanded his voluntary resignation. The Blue Cross Board of Directors accepted it, reluctantly, at their meeting of January 24, 1970, with appropriate ceremonies.

WHEREAS, it is impossible to portray in a written record the detailed contributions and sources of strength which this outstanding physician and gentleman has made to Blue Shield of Florida, Inc. during a period of many years.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF BLUE SHIELD OF FLORIDA, INC., that we express our great appreciation for his magnificent service to the public, to our and subscribers to Voluntary Prepayment Insurance Plans through his active participation and leadership as member of the Blue Shield Board and of the Blue Cross Board during a prolonged period of growth and increasing responsibilities.
