# SENATE LEGISLATION

## SB-12S-2595

1 *SB-12S-2595 UNF Surf Club*

2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government  
5 Senate, responsible for funding only those entities that comply with the Student Government  
6 mission which is to represent student concerns in all university wide matters while  
7 developing and promoting programs and activities of practical value and interest to students,  
8 and;

9 Whereas: This purchase or activity reflects the genuine students interest and enhances the educational,  
10 social, cultural, and recreational interests of the University of North Florida students and;

11 Whereas: The students of the UNF Surf Club, are Activity and Service fee paying students, looking to  
12 enhance the cultural and social interests of the students of the University of North Florida,  
13 and;

14 Whereas: The, UNF Surf Club, in order to further enhance the cultural and social interests of the  
15 students of the University of North Florida, are seeking funding for travel to the NSSA  
16 National Surf Competition from June 12, 2012 to June 18, 2012.

17 Whereas: The UNF Surf Club, is requesting funding for the below items:

18	Lodging:	2 Rooms X 4 Nights X \$89.66 per room per night	= \$717.28
19	Fuel:	2 vehicle X 8.65 miles per vehicle X \$3.80 per gallon	= \$65.74
20	Car Rental:	2 cars X 147.85 per vehicle	= \$295.70
21	Airfare:	2 students X \$410.60 per ticket	= \$821.20
22	Registration:	1 student X \$600.00	= \$600.00

25 **Total:** = \$2,499.92

28 that \$2,500 be expended from the Student Conference Travel Index 402028
