12 looking to enhance the cultural and social interests of the students of the University of North
13 Florida, and;
- 14 Whereas: The, Campus Crusade for Christ, in order to further enhance the cultural and social interests
15 of the students of the University of North Florida, are seeking funding for travel to the Puerto
16 Rico Project from May 25, 2012 to June 25, 2012;
