CA-06S-1982 : Clarification of Voter Eligibility

2 Whereas: The Student Government of the University of North Florida was established to
3 represent student concerns in all University wide matters, and;

4 Whereas: The Student Senate is the legislative body of the University of North Florida's
5 Student Government, given the responsibility of carrying out such legislative acts
6 that are necessary and proper for the Student Body of the University of North
7 Florida;

8 Whereas: Legislation dealing with necessary and proper statutory revisions shall be
9 considered by the Student Senate;

10 Whereas: The Constitution and Statutes Committee is responsible for making revisions to
11 the Student Government Constitution and Statutes as needed, and;

Whereas: The Constitution is in need of revision;

13 Whereas: The University of North Florida's Student Government Constitution requires
14 clarification to ensure no law is enacted which may unfairly hinder a student's
15 right to vote;

16 **Therefore:** Let it be enacted, that a Constitutional Referendum be placed on the ballot
17 for the Spring 2006 General Election by the Elections Supervisor, and;

18 **Further:** Let it be further enacted, that the Referendum to be placed before the
19 student body be submitted as follow:

20 Article V: Elections
21 Section 1: Eligible Voters

22 G. Student Government will ~~make enact~~ enact no law to this Section which adds any
23 additional eligibility criteria ~~to this Section~~ or law which unfairly hinders a
24 registered student's right to vote.
