SENATE LEGISLATION

CA-06S-1984

1 *CA-06S-1984 : Validation of Election Results*

2 Whereas: The Student Government of the University of North Florida was established to
3 represent student concerns in all University wide matters, and;

4 Whereas: The Student Senate is the legislative body of the University of North Florida's
5 Student Government, given the responsibility of carrying out such legislative acts
6 that are necessary and proper for the Student Body of the University of North
7 Florida;

8 Whereas: Legislation dealing with necessary and proper statutory revisions shall be
9 considered by the Student Senate;

10 Whereas: The Constitution and Statutes Committee is responsible for making revisions to
11 the Student Government Constitution and Statutes as needed, and;

12 Whereas: The Constitution is in need of revision;

13 Whereas: The University of North Florida's Student Government Constitution is currently
14 lacking sufficient provisions outlining the process in which election results are
15 validated prior to the installation elected officials;

16 **Therefore: Let it be enacted, that a Constitutional Referendum be placed on the ballot**
17 **for the Spring 2006 General Election by the Elections Supervisor, and;**

18 **Further: Let it be further enacted, that the Referendum to be placed before the**
19 **student body be submitted as follow:**

20 Article V: Elections
21 ~~Section 6: Installation~~
22 Section 6: Validation

23 In the absence of a legitimate challenge to the validity of the entire General,
24 Inter-College, or Special Elections, the Student Senate shall validate election
25 results no later than ten (10) business days after the last day of the election.
