# SENATE LEGISLATION

## SB-06F-2060

1 *SB-06F-2060 : UNF Intramural Sports*

2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government  
5 Senate, responsible for funding only those entities that comply with the Student Government  
6 mission which is to represent student concerns in all university wide matters while  
7 developing and promoting programs and activities of practical value and interest to students,  
8 and;

9 Whereas: This purchase or activity reflects the genuine students interest and enhances the educational,  
10 social, cultural, and recreational interests of the University of North Florida students and;

11 Whereas: Student Government has the obligation to promote student activities and service their general  
12 interests;

13 Whereas: The UNF Intramural Sports trainer position exists to ensure a safer environment  
14 in which to play competitive sports, to eliminate unnecessary hospital trips for  
15 injured participants, and saving students money.

16 Whereas: The Intramural Sports trainer position established will be used for student  
17 enhancement. For the organizations complete success it is requesting:

18	Athletic Training Tape	\$49.99 X	1	\$49.99
19	Hourly- rate Athletic Trainer	\$14.00 X	388	\$5432
20	Hourly-rate First Responder	\$9.00 X	240	\$2160

21 **Total: \$8222.78**

22 **Therefore:** Let it be enacted, by the University of North Florida Student Government, that  
23 \$8,222.78 be transferred from the Special Request Index 402097 to Recreation  
24 Index 402030 to be used to pay for the above referenced athletic trainers wage.
