- 1 **SB-06F-2064: Melissa A. Bright travel to Knoxville**
- 2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;
- 4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government
5 Senate, responsible for funding only those entities that comply with the Student Government
6 mission which is to represent student concerns in all university wide matters while
7 developing and promoting programs and activities of practical value and interest to students,
8 and;
- 9 Whereas: This purchase or activity reflects the genuine student interest and enhances the educational,
10 social, cultural, and recreational interests of the University of North Florida students and;
- 11 Whereas: Melissa A. Bright's mission is to attend a Conference for the Society for
12 Southeastern Social Psychology.
- 13 Whereas: Melissa A. Bright wishes to travel to the Conference for the Society for
14 Southeastern Social Psychology, in Knoxville, Tennessee on November 10th thru
15 November 12th, 2006.
- 16 Whereas: Below is the following breakdown of the amount being requested:
- 17 Airfare: \$354.00 x 1
- 18 **Total: \$354.00**
- 19 **Therefore: Let it be enacted, by the University of North Florida Student Government,**
20 **that \$354.00 from the Travel Request Index 402028 be used to pay for travel**
21 **to the Conference for the Society for Southeastern Social Psychology.**
