### SB-06F-2076: Jacksonville Christian Life

2 Whereas: The Student Government of the University of North Florida was established to represent student  
3 concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government Senate,  
5 responsible for funding only those entities that comply with the Student Government mission which is  
6 to represent student concerns in all university wide matters while developing and promoting programs  
7 and activities of practical value and interest to students, and;

8 Whereas: This purchase or activity reflects the genuine student interest and enhances the educational, social,  
9 cultural, and recreational interests of the University of North Florida students and;

10 Whereas: Student Government has the obligation to promote student activities and service their general  
11 interests;

2 Whereas: Jacksonville Christian Life club exists to provide leadership to college students at UNF  
13 by magnifying HIM in worship, building habits of maturity within our home groups,  
14 equipping each saint to be involved in gift-oriented ministry, and building a need-based,  
15 mission-minded culture.

16 Whereas: Jacksonville Christian Life wishes to attend the Faithwalkers 2006 conference,  
17 December 27-31, 2006 at the Tan-Tar resort in Lake of the Ozarks, Missouri.

18 Whereas: The JCL Bill is for student enhancement. For the organization's complete success  
19 they are requesting:
