1		SB-06S-1987 : UNF Tailgating
2 3	Whereas:	The Student Government of the University of North Florida was established to represent student concerns in all University wide matters, and;
4 5 6 7 8	Whereas:	The Budget and Allocations Committee is a standing committee of the Student Government Senate, responsible for funding only those entities that comply with the Student Government mission which is to represent student concerns in all university wide matters while developing and promoting programs and activities of practical value and interest to students, and;
9 10 11	Whereas:	This purchase or activity reflects the genuine student interest and enhances the educational, social, cultural, and recreational interests of the University of North Florida students and;
12 14	Whereas:	It is essential for the University of North Florida's Student Government to promote and support school spirit within the UNF community and amongst the student body;
15 16 17	Whereas:	Providing funding for the UNF tailgating events will not only provide a service to the student body but also help increase school spirit and athletic support, which is necessary for the growth of the University of North Florida;
18		Total : \$2,608.34
19 20 21	Therefore:	Let it be enacted, by the University of North Florida Student Government, that \$2,608.34 be transferred from the Special Request Index 402097 to Special Projects Index 402081 be used to pay for the UNF Tailgating events.
