SB-06S-1991

1 **SB-06S-1991 : Access 218 Travel**

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters.

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government
5 Senate, responsible for funding only those entities that comply with the Student Government
6 mission which is to represent student concerns in all university wide matters while
7 developing and promoting programs and activities of practical value and interest to students.

8 Whereas: This purchase or activity reflects the genuine student interest and enhances the educational,
9 social, cultural, and recreational interests of the University of North Florida students.

10 Whereas: Access 218's mission is to promote team leadership, and gain mentoring and
11 leadership skills that will inspire passion for the betterment of their club at this
conference.

13 Whereas: Access 218 wishes to travel to Atlanta Georgia for the Thirsty Convention on
14 March 28th -April 1st, so that they may learn new methods of mentoring and
15 leadership and provide the students with skills that will promote team building.

16 Whereas: Below is the following breakdown of the amount being requested:

17 Registration: \$129.00 x 4 students \$516.00

18 Transportation: 1 car x 174.00 \$174.00

19 **Total: \$690.00**

20 **Therefore: Let it be enacted, by the University of North Florida Student Government,**
21 **that \$690.00 from the Travel Request Index 402028 be used to pay for Access**
22 **218 to travel to the Thirsty Conference in Atlanta, GA, on March 28th- April**
23 **1st .**
