SB-06S-1997 : Title VIII Revisions

2 Whereas: The Student Government of the University of North Florida was established to
3 represent student concerns in all University wide matters, and;

4 Whereas: The Student Senate is the legislative body of the University of North Florida's
5 Student Government given the responsibility of carrying out such legislative acts
6 that are necessary and proper for the Student Body of the University of North
7 Florida;

8 Whereas: Legislation dealing with necessary and proper statutory revisions shall be
9 considered by the Student Senate;

10 Whereas: The Budget and Allocations Committee is responsible for making revisions to
11 Title VIII of the Student Government as needed, and;

12 Whereas: Title VIII is in need of revisions;

14 **Therefore: Let it be enacted, that the following changes be made to Title VIII:**

15 802.5 12. Monetary Prizes, Raffles, and Prizes in excess of \$25 dollars

16 Chapter 815 SG Accountant(s)

17 815.11 The SG Accountant(s) shall serve as Payroll Certification backup to the
18 SG Office Manager

19 ~~816.3 The Fiscal Assistant shall serve as Payroll Certification backup to the SG~~

22 831.6 ~~Any publications or notice of an event funded by the A&S Fees Budget~~

The violating account, Club and/or Organization shall be placed immediately on probation for a period of one year from the date of the infraction.

833.8 ~~Any publications or notice of an event funded by the A&S Fees Budget~~ printed items purchased all or in part by A&S Fees shall be required to either have the statement "Funded by UNF Student Government" or a similar statement approved by the SG Comptroller. Failure to comply places the RSO in direct violation of the Finance Code. The violating RSO account shall be placed immediately on probation for a period of one year from the date of the infraction.

841.3 ~~Food associated with travel shall not be requested nor paid for with A&S Fees.~~ may be requested at the State rate for per-diem if not included in the registration fee.
