## SB-06S-2005

### SB-06S-2005: 2006-2007 Activity and Service Fee Fiscal Budget

- 2   Whereas:   The Student Government of the University of North Florida was established to represent  
3                   student concerns in all University wide matters, and;
- 4   Whereas:   The Budget and Allocations Committee is a standing committee of the Student Government  
5                   Senate, responsible for funding only those entities that comply with the Student Government  
6                   mission which is to represent student concerns in all university wide matters while  
7                   developing and promoting programs and activities of practical value and interest to students,  
8                   and;
- 9   Whereas:   The 2006-2007 Balanced Budget, with provisionary language or riders, was placed on  
10                  display in the SG office on February 20<sup>th</sup>, 2006 at 8:00 am and;
- 11   Whereas:   The Open Forum was held on March 1<sup>st</sup>, 2006 at 12:00 pm and;
- 12   Whereas:   Title VIII states in 822.2 "The B&A approved budget shall be posted within two business  
13                  days of approval and shall be displayed in public view for a minimum of five business days  
14                  prior to the Senate meeting in which it will be placed on the agenda. During this period, a  
15                  campus-wide open forum will be conducted by the B&A Chairperson to explain the budget  
16                  process and the B&A recommended budget," and;
- 17   **Therefore:   Let it be enacted, by the University of North Florida Student Government,**  
18                  **that the proposed attached 2006-2007 Balanced A&S Fee Fiscal Budget be**  
19                  **accepted with provisionary language and riders.**
