## SB-06SA-2028

### *SB-06SA-2028 : Title II – Reorganization*

2 Whereas: The Student Government of the University of North Florida was established to  
3 represent student concerns in all University wide matters, and;

4 Whereas: The Student Senate is the legislative body of the University of North Florida's  
5 Student Government, given the responsibility of carrying out such legislative acts  
6 that are necessary and proper for the Student Body of the University of North  
7 Florida;

8 Whereas: Legislation dealing with necessary and proper statutory revisions shall be  
9 considered by the Student Senate;

10 Whereas: Title II is in need of minor revision;

11 Whereas: The organization of laws does not jive with the decimal structure that is  
12 emphasized.

13 Whereas: The following revisions will be made to Title II:

### 14 **Chapter 200 Parliamentary Authority**

200.1. A. The Student Government parliamentary authority shall be the current  
21 edition of Robert's Rules of Order.

200.2. B. Robert's Rules of Order shall be the authority for all formal and  
25 announced Student Government meetings.

200.3. C. Robert's Rules of Order shall be the authority only over those  
29 questions that have not been specified by general law or university  
30 regulations, or by the Constitution of the Student Government of the  
31 University of North Florida, Student Government Statutes or Senate
