### SB-06SA-2037: *Student Nutrition Club Travel*

- 2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;
- 4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government  
5 Senate, responsible for funding only those entities that comply with the Student Government  
6 mission which is to represent student concerns in all university wide matters while  
7 developing and promoting programs and activities of practical value and interest to students,  
8 and;
- 9 Whereas: This purchase or activity reflects the genuine student interest and enhances the educational,  
10 social, cultural, and recreational interests of the University of North Florida students and;
- 11 Whereas: The Nutrition Clubs mission is to increase and spread awareness of nutrition and  
12 healthy lifestyle;
- 13 Whereas: The Nutrition Club wishes to travel to the FL Dietetic Association Annual  
14 Symposium in Orlando, FL, on July 10, 2006- July 12, 2006, so that they may  
15 gain information concerning Dietetic Education.
- 16 Whereas: Below is the following breakdown of the amount being requested:

- 21 **Therefore:** Let it be enacted, by the University of North Florida Student Government,  
22 that \$1,311.79 from the Travel Request Index 402028 be used to pay for the  
23 Nutrition Clubs travel to the FL Dietetic Association Annual Symposium in  
24 Orlando, FL, on June 10-12<sup>th</sup>.
