### *SB-06SB-2038 : Volunteer Center*

- 2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;
- 4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government  
5 Senate, responsible for funding only those entities that comply with the Student Government  
6 mission which is to represent student concerns in all university wide matters while  
7 developing and promoting programs and activities of practical value and interest to students,  
8 and;
- 9 Whereas: This purchase or activity reflects the genuine student interest and enhances the educational,  
10 social, cultural, and recreational interests of the University of North Florida students and;
- 11 Whereas: Student Government as the obligation to promote student activities and service  
their general interests;
- 13 Whereas: The Volunteer Center exists to enhance student social interests and bring  
14 awareness to their Student Government.
- 15 Whereas: The Volunteer Center Bill is for student enhancement on this campus. For the  
16 Agency's complete success the following allocations have been requested;
- 17 1 Lateral filing Case: \$538.00
- 18 **Total: \$538.00**
- 19 **Therefore: Let it be enacted, by the University of North Florida Student Government, that \$538**  
20 **from the Special Request Index 402097 transferred to the Special Projects Index**  
21 **402081 to be used to pay for the above referenced request supplies.**
