# SENATE LEGISLATION

## SB-06SB-2039

1 *SB-06SB-2039 : Student Advocacy Committee Scantrons*

2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government  
5 Senate, responsible for funding only those entities that comply with the Student Government  
6 mission which is to represent student concerns in all university wide matters while  
7 developing and promoting programs and activities of practical value and interest to students,  
8 and;

9 Whereas: This purchase or activity reflects the genuine student interest and enhances the educational,  
10 social, cultural, and recreational interests of the University of North Florida students and;

11 Whereas: Student Government as the obligation to promote student activities and service  
12 their general interests;

13 Whereas: Student Advocacy Committee is aimed to enhance student social interests and  
14 bring awareness to their Student Government Elections. This will promote student  
15 involvement in campus activities.

16 Whereas: The S.A.C. Bill is for student enhancement on this campus. For the Committee's  
17 complete success the following allocations have been requested;

18 5,000 Scantrons, Form #2052: \$630.00

19 5,000 Scantrons, Form #882: \$540.00

20 5,000 Scantrons, Form #F289-PAR-L: \$337.50

21 5,000 Scantrons, Form #22993-PAR-L: \$415.00

22 HANDLING: \$10.00

23 Delivery: 111.02
