SB-06SB-2041

1 *SB-06SB-2041 : Student Advocacy Committee Newsletter*

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government
5 Senate, responsible for funding only those entities that comply with the Student Government
6 mission which is to represent student concerns in all university wide matters while
7 developing and promoting programs and activities of practical value and interest to students,
8 and;

9 Whereas: This purchase or activity reflects the genuine student interest and enhances the educational,
10 social, cultural, and recreational interests of the University of North Florida students and;

11 Whereas: Student Government as the obligation to promote student activities and service
12 their general interests;

13 Whereas: The S.A.C. Committee is aimed to enhance student social interests and bring
14 awareness to their Student Government Elections. This will promote student
15 involvement in campus activities.

16 Whereas: The S.A.C. bill is for student enhancement on this campus. The SG Newsletter
17 will supply students with Student Government updates and announcements. For
